

## **Privacy Policy and Confidentiality Statement**

We respect the personal data of every visitor to [www.restaurantsname.gr](http://www.restaurantsname.gr). This text (called the Privacy Policy and Privacy Statement - hereinafter referred to as the "Statement") explains in simple terms but also clearly how we process the personal data we collect from you or that you provide to us. Please consider carefully this Statement to inform you of how we collect, store, use, transmit and protect the information / personal information we receive from you:

### **Generally:**

Restaurant's Name collects and retains solely the personal information you disclose by entering the requested personal information in the relevant fields and / or your responses to specific actions taken by Restaurant's Name and you may voluntarily participate and be the minimum necessary for its proper operation.

As part of its obligation to safeguard and protect the information of its customers, Restaurant's Name is committed to protecting and using, as appropriate, the personal information (hereinafter "personal data") collected either online or through this website. / collaboration with every third party. As part of the registration process, we collect and process the following information:

### **Required information:**

- Name
- E-mail
- Order address
- IP
- Telephone number
- Cellphone number
- Tax information (in case of invoice)

Restaurant's Name collects only the personal data voluntarily provided by you, our online visitors, so that we can meet your specific requests, so that we can provide you with information about our products and services and to serve you optimally. way. Where additional, optional information is sought, you will be informed at the time of collection.

By subscribing to the services provided by [www.restaurantsname.gr](http://www.restaurantsname.gr) you also consent to the storage and use of your personal information in accordance with this Statement. We may process your personal data in order to provide personalized services under the law (Article 6 (1b) of Regulation (EU) 2016/679). Your personal data is not used for any purpose other than as described in the Statement, unless we obtain your prior permission, or unless required or permitted by law. The purpose of collecting, using and processing your personal data is (a) to provide the services and products you request through the Website, the use of which requires your use and / or processing, for example. online orders and the consequent fulfillment of contractual obligations, in the context of the most efficient and effective execution, delivery and pricing of orders, (b) the promotion of products and services provided by Restaurant's Name in particular through [www.restaurantsname.gr](http://www.restaurantsname.gr), (c) providing personalized services and facilitating the ordering process for the convenience of the user

and / or ensuring that the content of the Website is presented in the most efficient way for you and your computer.

Restaurant's Name collects "sensitive" personal data only when you voluntarily provide us with this data or when such data is required or required by law. We advise you to refrain from providing sensitive data unless this is required for the purpose of providing your personal data or if you hereby consent to the use by Restaurant's Name of such data for its purposes.

Restaurant's Name may ask you to provide certain personal information about us to send information on products and services and / or related offers and announcements. Restaurantsname.com may also ask for your permission for certain uses of your personal information and you can either consent or deny these uses. If you would like specific services or communications, such as an electronic newsletter, you will be able to unsubscribe from the relevant recipient list at any time by following the instructions in each communication. If you decide to opt out of a service or communication, we will try to delete your data as soon as possible, although we may need some time and / or information before we can process your request.

## **2. Access to Personal Data and Rights**

If you wish, you may at any time request information about your personal data held by Restaurant's Name, their addresses, the purpose of their keeping and processing, as well as their modification, correction or deletion, by sending an email to [info@restaurantsname.gr](mailto:info@restaurantsname.gr) from the email address you have indicated, attaching a copy of your police ID. You also have the right to review the personal data we hold and to exercise in general any right provided for by personal data protection law.

The personal data that you disclose to Restaurant's Name through [www.restaurantsname.gr](http://www.restaurantsname.gr), either during your registration or at a later stage, is collected and used and processed in accordance with applicable personal data protection laws. and in particular, in accordance with the provisions of Law 2472/1997 and Law 3471/2006, as well as the new European General Data Protection Regulation (EU) 2016/679 and Directive 95/46 / EC protection of personal data.

You reserve the following rights in detail:

- Right to information about your personal data: Upon request, we will provide you with information about the personal data we hold about you.
- Right to Correct and Supplement Your Personal Data: If you notify us, we will correct any inaccurate personal data relating to you. We will complete incomplete data if you give us notice, provided that such data is necessary for the purpose of processing your data.
- Right to delete your personal data: At your request, we will delete the personal data we hold about you. However, some data will only be deleted after a specified retention period, for example because in some cases we are legally required to retain the data, or because the data is required to fulfill our contractual obligations to you.

- **Right to Freeze Your Personal Data:** In some cases provided for by law, we will block your data at your request. Further processing of captive data is done only to a very limited extent.
- **Right to Withdraw Your Consent:** You may at any time revoke your consent to the processing of your personal data in the future. The legality of processing your data remains unaffected by this action, up to the point of withdrawal of your consent.

Your right to object to the processing of your data: You may at any time object to the processing of your personal data in the future if we process your data on the basis of one of the legal justifications provided for in Article 6 (1e or 1f) of Regulation (EU) 2016/679. If you object, we will stop processing your data, provided there are no legitimate reasons for further processing. Editing your data for advertising purposes is not a legitimate reason.

### **3. Transmission of Personal Data**

Restaurant's Name does not share or transmit personal data to third parties, unless required for legitimate business and business needs, to respond to your requests and / or where required or permitted by law. In any event, access to your personal data shall only be authorized by authorized persons who are required to have access in order to be able to complete the purposes of their collection, use and processing as disclosed in this Statement.

In some cases, Restaurant's Name may share your personal information with various companies or service providers that work with it to respond to your requests or to the natural or legal persons who have been assigned to the processing, provided that that we will inform you in advance and obtain your prior consent. Individuals with access to the data are required to respect the confidentiality of this data.

Restaurant's Name reserves the right to use the information you disclose through [www.restaurantsname.gr](http://www.restaurantsname.gr) in such a way that it cannot be identified or disclosed for statistical, promotional, research or advertising purposes. by notifying them to third parties, e.g. research companies responsible for accomplishing the above objectives.

Restaurant's Name may transfer certain personal data outside of geographical boundaries to other companies that work with it and / or store personal data in a jurisdiction other than that in which you are located. By providing their personal data online, visitors consent to such transfer and / or storage of their personal data abroad.

Restaurant's Name may store your personal data in the cloud. This means that your personal data may be processed by a cloud service provider on behalf of Restaurant's Name and your personal data may be stored in different locations around the world. The Company uses organizational and contractual measures to protect personal data and to impose similar, but never less restrictive, requirements on our cloud service providers, including requirements for the exclusive processing of your personal data for them in this Statement aims.

### **4. Security of Personal Data**

Restaurant's Name applies specific technical and organizational security procedures to protect personal data and information from loss, misuse, alteration or destruction. Our partners who support us in the operation of this site also comply with these provisions.

Restaurant's Name makes every reasonable effort to maintain the personal data collected only for the period for which it is required for the purpose for which it was collected or until it is requested to be deleted (if this is the case), unless continue to observe them in accordance with the legislation in force.

## **5. Revisions to the Declaration**

Restaurant's Name reserves the right to modify or revise this Statement from time to time, at its sole discretion. In the event of any changes, Restaurant's Name will record the date of modification or revision to this Statement and the updated Statement will be effective for you from that date. We encourage you to review this Statement periodically to see if there are any changes to the way we handle your personal information. This Statement was last updated on April 26, 2018.

## **Cookies Policy**

This policy explains how Restaurant's Name uses Cookies when you browse corleone.gr and in our mobile application on mobile and tablet devices. By accepting this Policy, you confirm that you have accepted and been informed of the use of our Cookies in the browser you use.

### **What are Cookies?**

Cookies are small data files consisting of texts and numbers stored in your browser (Chrome, Mozilla Firefox, Internet Explorer) containing information that allows the site to remember important information that will make use of [www.corleone.gr](http://www.corleone.gr) more effective and useful for you. Cookies allow us to recognize your device and enable specific information to make your navigation easier, such as the store that serves you. Cookies help you maintain your personal settings and help us customize our site accordingly.

### **Can I not use Cookies?**

You can choose to disable cookies from your browser settings as well as delete all cookies that have recently been stored in the browser. You can find more instructions by clicking Help in the browser menu. However, you should be aware that disabling cookies from your browser may not allow you to take advantage of all the features of the site and some of the features of the site may not work as they should as they rely on cookies.

## **Use of cookies by Restaurant's Name**

At Restaurant's Name we use Cookies, but without collecting, processing or storing personal data from its use. We use cookies and IP technology to obtain non-personal information from our visitors and to provide our registered visitors with the best personalized online experience possible. By browsing our site, we collect simple identification and metrics, such

as how many users visited specific sites on our site. Using cookies does not in any way harm your computer or mobile device. Cookies can also be used for online remarketing.

### **Original Manufacturer Cookies**

Initial Manufacturer cookies are cookies that are used either by restaurantsname.com or by third parties using the domain of our site. For example, restaurantsname.com uses cookies from Google Analytics

### **Third Party Cookies**

Third-party cookies are created in your browser by a different site than the one you are browsing (in this case different from Restaurant's Name). Such Cookies may be cookies from DoubleClick for the evaluation of third-party marketing activities

We are permitted to process data in this technological context under the law (Rule 6 (1f) of Regulation (EU) 2016/679). We store this data until the cookie expires or you delete it.
